

FCC APPLICATION PROCEDURE

- Complete FCC Form 160-(CORES) Registration, online at the FCC web page (<u>https://apps.fcc.gov/coresWeb/publicHome.do</u>).
 You will be assigned a FRN (FCC Registration Number) that will be used on Form 601.
- 2. Please note, you cannot proceed with the following steps without your assigned FRN.
- Complete all highlighted areas in FCC Form. The processing fee is \$405.00 and the check is made payable to The Monitoring Association. Please note that for each additional location(s), an additional fee of \$200 will apply.
- 4. Return all completed forms and checks to AES Corporation for processing on your behalf.

IMPORTANT Please Read

The FCC must be notified by a filing of Schedule K within 12 months of the receipt of your license. Failure to do so will result in your license being *terminated*!

You have within one (1) year of receiving the FCC license to complete the Schedule K form. If a year lapses without filling the Schedule K form, you could lose your FCC license. Below are steps to file your Schedule K online, note there are no filing fees:

- 1. Go to <u>http://wireless.fcc.gov/.</u>
- 2. Click on hyperlink 'Licensing & Databases' located on the top of the web page.
- 3. Scroll down to the bottom of the web page and click on the hyperlink 'Universal Licensing System (ULS)'.
- 4. On the middle of the web page, click the 'File Online' button which is located in the Online Filing section.
- 5. You will be prompted to enter the FCC Registration Number (FRN) and password, then click on the 'Submit' button.
- 6. Once logged in, click 'S'...continue.
- 7. Complete the questions, signoff and print out completed form for your records.
